Each coin-operated machine must have a serial number that is clearly visible on the OUTSIDE of the machine. If a machine is manufactured without a serial number, the machine owner must assign a serial number and stamp or engrave the number on the machine.

An Occupation Tax Permit sticker issued by the City of Corpus Christi MUST be affixed to each registered machine when it is placed on location. Occupation Tax Permit sticker must be securely attached to the machine.

Any person who intentionally removes a current Occupation Tax Permit from a machine is subject to criminal prosecution.
