THE RESPONSIBILITY FOR CODE COMPLIANCE, INSTALLATION INTEGRITY, AND ANY RESULTING FAILURES, HAZARDS, OR DAMAGES RESTS SOLELY WITH THE THIRD PARTY PERFORMING THE WORK, THE CONTRACTOR OF RECORD AND THE STATUTORY FRAMEWORK PERMITTING SUCH THIRD-PARTY PROCESSES. ISSUANCE OF THIS PERMIT DOES NOT IMPLY VERIFICATION, VALIDATION, OR APPROVAL BY THE CITY'S INSPECTIONS DEPARTMENT.

FEES ARE NON-REFUNDABLE ON PERMITS WHERE WORK HAS ALREADY COMMENCED. IF WORK HAS STARTED, WITHDRAWAL IS ONLY ALLOWED WHEN NO INSPECTION HAS BEEN MADE AND THE BUILDING OFFICIAL DETERMINES THAT THE EXISTING WORK DOES NOT VIOLATE ANY CODE OR ORDINANCE. A PERMIT MAY NOT BE WITHDRAWN UNLESS A SUBSEQUENT PERMITTEE HAS OBTAINED A PERMIT TO COMPLETE THE WORK. PERMIT FEES EXCEEDING \$100.00 MAY BE PARTIALLY REFUNDED. WHERE APPLICABLE, REFUNDS WILL BE ISSUED AT 80% OF THE ORIGINAL VALUE, EXCLUDING PLAN REVIEW AND FIRE PROTECTION PLAN REVIEW DEPOSITS. PERMITS MAY BE WITHDRAWN BY THE APPLICANT IF NO WORK HAS COMMENCED ON THE PROJECT. WITHDRAWN PERMITS WITH FEES OF \$100.00 OR LESS ARE NON-REFUNDABLE. CONTRACTOR REGISTRATION FEES ARE NON-REFUNDABLE.
